

JENNINGS COUNTY COMMISSIONER MEETING  
February 6, 2025, 6:00 P.M.

Matt Sporleder, Alex Zimmerman, Shane Boswell, and Charlie St. John were present. Matt opened the meeting with the Pledge of Allegiance.

Justin Fox submitted three quotes for new doors (4 total) at the Probation office.

Doors Equipment - \$21,600.00

Scottsburg Glass - \$15,164.00

Glass Unlimited - \$19,994.00

These quotes do not include the key fob system on the doors. Randy Taggart will have to come and quote this after the doors are installed. Justin said that his recommendation would be Scottsburg Glass and Glass Unlimited. Matt said that if Justin feels that all three quotes are equal then he suggests moving forward with Scottsburg Glass. Shane made a motion to approve the quote from Scottsburg Glass, contingent on council finding the funding. Charlie seconded the motion, passed unanimously.

Matt said that the commissioners have received a letter of support from Comcast. Alex explains that Comcast is applying for a broadband development grant that is administered by the state broadband office. Alex goes on to explain that Comcast is just asking for a letter of support from the commissioners. Matt says that he received a phone call from Frontier also asking for a letter of support. Matt suggests that they issue both Comcast and Frontier the letter of support. Only one of these two companies will get the grant, and Matt says that it is not the commissioner's place to pick and choose which one received it. Frontier has not submitted a letter to the commissioners yet so the commissioners will only sign the Comcast letter. Shane made a motion to sign the letter of support, Charlie seconded the motion, passed unanimously.

Brian Hatfield, President of the Campbell Township Water Board explains that they have done some restructuring. Charlene has stepped away from the board and Brian would like to replace her with Jack Kelly. Jack is president of the North Vernon City Council, and he spent eight years on the North Vernon Utility Board. Brian explains that Jack is willing to work hard and wants to help with the sewer problem in Butlerville. Currently the board members are Brian, Jim Beeman, and Marty Steining.

Nicci submits a travel request for the clerk to attend the Southern Indiana District Clerks Conference. All funds will be paid out of the clerk's budget. Charlie made a motion to approve the request, Shane seconded the motion, passed unanimously.


Gleeda Hadley, introduces herself as the coordinator of the Jennings County Drug and Alcohol Task Force. She wanted to let the commissioners know that the annual comprehensive community action plan is coming due in April and that they are making changes to the plan. It will be a live document that anyone can comment on.

Shane made a motion to approve prior minutes, Charlie seconded the motion. Passed unanimously.
